- **"Money In Politics"** an LWVUS update study. Wednesday August 26 at 6pm. This study will be our December and January programs.
- 18th Congressional District **Candidate Forum** on Monday, August 31. Want to ask a question? Want to be in the audience? Watch your email for more information. Let's make sure our two candidates hear that we want issue oriented campaigning. And, whoever gets elected, we expect them to decide their votes in Congress based on the merits of an issue, not which political party proposed a solution.

**DRINKS & DIALOGUE, Toxic Chemicals**

**Wednesday, August 19** from 5:30pm to 6:30pm at the Hearth Restaurant at 4604 N. Prospect Road, Peoria Heights.

*The Prevalence of Toxic Chemicals and Lack of Federal Regulations* will be discussed at Drinks & Dialogue, a program hosted by our League. Many people are unaware of the toxic chemicals they are exposed to on a regular basis and don't realize that many countries have banned chemicals that are routinely used in the United State. The League is committed to reducing exposure to all pesticides and encourages the use of non-toxic alternatives.

The dialogue about toxic chemicals and the lack of federal regulations will be facilitated by League member Nora Sullivan and opened by **Clare Howard**, the managing editor of the monthly newspaper Community Word and a former Peoria Journal Star reporter, who wrote a three-part series about pesticide drift with a George Polk Investigative Reporting grant funded by the Ford Foundation.

Drinks & Dialogue provides an opportunity for people to share opinions and ideas, ask questions and become more aware of local, state and national issues and the options for making change. There's no cost to participate, and refreshments are available to buy.

## THE RESULTS ARE IN.....

A dedicated group of 21 LWVGP volunteers went into action "Making Democracy work" on Friday, July 24<sup>th</sup> in Springfield, IL. Following months of intensive preparation and meetings, the LWVGP conducted the 17<sup>th</sup> biennial Vietnam Veterans of America (VVA) National Board of Directors election. The volunteers successfully conducted both the voting and ballot counting processes for over 750 VVA delegates from nine (9) regions from across the country.

Each two years since 1987, the VVA contacts a League in the area where their biennial convention is held and asks that League to conduct their election. Since a League does not currently exist in Springfield, the LWVGP was contacted and selected to conduct the election. Scott DeArman, Chair of the VVA Election Committee, and his team worked with the LWVGP to prepare for the 2015 election. Fran Kepler and Farrell Davies co-chaired the LWVGP effort with generous and abundant support from Pat Landes and Cheryl Budzinski.

Watching the VVA members come proudly through the voting lines wearing symbols of their war experience, many of us could not help but think back to the country's experience of the war over 50 years ago. We reminisced about our brothers, our husbands, and our friends who had been in the war and about the impact it has had on their lives and their families' lives. We also acknowledged the difficulties that led to the Founding Principle of the VVA, "**Never again will one generation of veterans abandon another.**" It was a privilege, therefore, to be there to offer our support to these men and women who served us courageously and selflessly.

The election is over and the results are in. The VVA officially announced and posted their new officers and directors. And, both the LWVGP and the VVA agree that the election process was a great success. Scott DeArman was especially happy to be able to present the results on Friday night instead of Saturday morning as a result of the LWVGP effective and efficient work.

**The VVA presented our League with an impressive plaque to thank us. VVA covered the cost of supplies for the election and travel for the volunteers. A contribution of \$1,000 was made to the LWVGP Education Fund for the work the volunteers did to conduct the election.**

A special joy and benefit of this project is the chance to talk with other Leagues who have conducted the election in their community. We were fortunate to get support from the Jacksonville, Florida League which conducted the 2013 election. The next election will be conducted in New Orleans, LA in 2017 and the LWVGP will offer support and assistance!

From Day One, I was surrounded with the expertise, support, and information that I needed from this wonderful group of three LWVGP volunteers; Fran Kepler, Pat Landes and Cheryl Budzinski. **My volunteer experience gave me what I hoped for-** I learned about elections and gave back to the veterans- and more- I got to know the LWVGP members better and experienced firsthand the value of the League "Making Democracy work."

#### LWVUS Statement on Campaign Finance, 1974 and revised 1982

The League of Women Voters of the United States believes that the methods of financing political campaigns should ensure the public's right to know, combat corruption and undue influence, enable to compete more equitably for public office and allow maximum citizen participation in the political process. *(This position is applicable to all federal campaigns for public office - presidential and congressional, primaries as well as general elections. it also may be applied to state and local campaigns.)*

**SEPTEMBER GENERAL MEMBERSHIP MEETING:** On Thursday September 3, at 6 pm, at the AMT building, the featured speaker will be **Cynthia Canary** the current Director and Campaign Manager of the Independent Map movement. Ms. Canary also currently serves on The Committee for Economic Development. Canary and political scientist Kent Redfield in 2014 co-authored "Backroom Battles and Partisan Deadlock," a 63 page report about four decades of legislative redistricting in Illinois and documented the highly partisan system lacking in transparency, limiting voter choices and placing political interests ahead of minority voting rights (available online at Change Illinois.) She previously served on the Illinois Campaign for Political Reform. Cindi is a graduate of Georgetown University. Please plan to attend, we want to display our commitment and enthusiasm for this significant effort for reform and good government.

### ***What are we doing now to get petition signatures?!***

- **Cyd's Gourmet Kitchen Café** in Junction City Shopping Center, Peoria, IL 61614 will be the place for voters to sign redistricting reform petitions, get finished petitions notarized, or pick up petitions from 10 am until noon each Saturday in August, September and October, 2015. Leaguers who are notaries will staff this.
- League volunteers will be at **Lindy's Market**, 110 Washington Square, Washington, IL 61571 on Saturday, Aug. 15 and Saturday, Sept. 12 from 10 am-2 pm to collect signatures and hand-out petitions
- League volunteers will be at **Haddad's Supermarket**, 2407 W Rohmann Ave. West Peoria, IL 61604 on Saturday, August 15 from 9 am to noon to collect signatures and hand-out petitions.

The League is collecting signatures to get an Amendment on the November 2016 ballot so the voters can decide if an independent commission should draw the state legislative district lines. Registered voters are encouraged to sign a petition, get a petition to collect signatures, or get their completed petitions notarized and turned in. Over 300,000 valid signatures will be required to place the measure on the Nov. 2016 ballot.

Independent Map Amendment reports that ***over 200,000 signatures have been collected*** so far. We need to get many more signatures!

This good government effort would change the way district lines are drawn for the Illinois House and Senate, from politicians drawing the district lines to an independent commission drawing the district lines. This would stop gerrymandering and hopefully lead to more competitive districts and more candidates running.

Petitions also are available at most Chambers of Commerce offices and notaries are available at those locations. (Call first)


