From LWVUS: **Supreme Court Rules in Key Judicial Campaign Finance Case**This week the <u>U.S. Supreme Court ruled 5-4 in an important campaign finance</u> case *Williams-Yulee v. Florida Bar*, upholding a state ban on direct campaign solicitations by judicial candidates. The League of Women Voters of the United States and the <u>League of Women Voters of Florida</u> joined <u>an amicus brief</u> on *Williams-Yulee v. The Florida Bar*, in favor of the constitutionality of a state prohibition because the public must have confidence in the independence and impartiality of judges.

CAUSES OF DEATH/PCCHD Observer Report

LOGO REPORT: Peoria County Health Department Board Meeting April 20, 2015.

The PCCHD epidemiologist compiled and presented a Peoria County Community Health Indicator Report for 2015. She will do this yearly from now. Her report has graphs and tables which are easy to view and understand. It was divided into four sections: Community Demographics, Health Outcomes, Leading Causes of Death, and Disease Prevalence for Peoria County. It compared these Peoria rates to all of Illinois and to the USA. Cancer is the leading cause of death in Peoria County closely followed by heart disease. Suicide is in 9th place. Diabetes is present in 10% of the population and obesity is also a significant problem in both adults and children.


