PRESIDENT'S MESSAGE

So many of us are sick of the dysfunction in Springfield and Washington DC. LWVGP would appreciate your help on several fronts.

- 1. Participate in the 18th Congressional candidate forum on Thursday, August 27. This will be televised live on WEEK-TV from 7-8 pm. Watch the forum on TV. Or, we need volunteers at the forum. And as a co-sponsor we have seats available in the audience. I need your name and anyone coming with you to the candidate forum by August 25. I will give you details if you email me at League@lwvgp.org
- 2. Support our League's efforts to collect petition signatures to put the *Redistricting Amendment* on the November 2016 ballot. This was the unanimous choice at our Annual Business meeting of what our League should work on. Cindi Canary, the speaker at our September 3 General Meeting, is well known in Illinois as a reformer. She should be a fascinating speaker. Ask her those difficult questions: "Why isn't this happening for Congressional seats!"
- 3. **Participate** on the committee **studying Amending the US Constitution**. Or, go to the November General Meeting which will be the consensus meeting on this issue.
- 4. **Learn** about **Money in Politics**. The new focus of campaigns is big money, and why is it so difficult to know: who did the political ad; why do some ads seem so irritating (is that on purpose?); do these ads work?
- 5. **Discuss** local issues at Drinks & Dialogue. Have you tried this League discussion group?

The September 10 election is different in several ways: a Thursday election day, only one ballot item, and citizens can now <u>register and vote on Election Day</u>. (Since we at League are so involved in registering voters, it is noteworthy that we can register also online which should appeal to younger voters.) The tricky thing about "Same Day" is that the voter must be in their correct polling place and they must have appropriate identification. (ID requirements same as our usual registration requirements.) This has potential to change campaigns and election outcomes, of course.

I hope that if we don't ask you directly to help or participate, please know that we would love for you to call or come to a meeting that interests you.

A sincere thank you to Leaguers Pat Landes, Mary McDade, and Carol May who did such an incredible presentation and event for the 50th Anniversary on August 6 of President Johnson signing the Voting Rights Act. And, thank you to our volunteers at the event and the ACLU and NAACP.

Illinois Government: Change or Status Quo? Redistricting Reform

Important Meeting Sept. 3 at 6pm

Our guest speaker for the September 3rd General Meeting is *Cynthia Canary the executive director for the Independent Map Amendment*. She has an extensive background working in good government organizations. The meeting takes place at 6 pm at the auditorium of the AMT building, 1718 N. Sterling.

REDISTRICTING NEWS

Registered Voters can sign redistricting petitions or get their completed petitions notarized at Cyd's Gourmet Kitchen Café in Junction City Shopping Center, Peoria, IL 61614 from 10 am until noon each Saturday in August, September and October, 2015. Leaguers will staff the events.

In addition the League will be at Lindy's Market, 110 Washington Square, Washington, IL 61571 on Saturday, Sept. 12 from 10 am-2 pm to collect signatures and hand-out petitions

The League is collecting signatures to get an Amendment on the November 2016 ballot so the voters can decide if an independent commission should draw the state legislative district lines. Registered voters are encouraged to come sign a petition, get a petition to collect signatures, or get their completed petitions notarized and turned in. Over 300,000 valid signatures will be required to place the measure on the Nov. 2016 ballot.

This good government effort would change the way district lines are drawn for the Illinois House and Senate, from politicians drawing the district lines to an independent commission drawing the district lines. This would stop gerrymandering and hopefully lead to more competitive districts and more candidates running.

Petitions also are available at most Chambers of Commerce offices and notaries are available at those locations. (Call first)

Constitutional Amendments Study: Be on the committee or get ready for the meeting

Here is a rare opportunity to participate in a national study by the LWVUS to determine our position on amending the U.S Constitution. Since we are a member-driven organization, the position will be created based on local Leagues all over the country studying the issue, presenting information to their local Leagues, and then reaching consensus (sense of the group) on a series of prepared questions. All of those responses will determine the LWVUS position for action and advocacy on this issue.

The LWVUS boils it down to: what are the shared values and beliefs within the League – what consensus do we have – regarding the circumstances that might allow or compel the League to endorse a constitutional amendment or an Article V Convention?

The basic process is

Establish a committee by early September. The committee provides background material and consensus questions in the monthly VOTER for August through November. Note the materials and questions have already been prepared by LWVUS for us to review; the committee may decide to address all or some of the questions). The committee arranges a program for the November 5 General Meeting (6pm at AMT, 1718 Sterling). The program could include a guest speaker. After the presentation, on the same night, the committee presents published consensus questions for members only to discuss and come to consensus (the sense of the group expressed through the exchange of ideas and opinions). Our League's responses are sent to the LWVUS, with those from Leagues all over the country, for the LWVUS to draft our organization's position on constitutional amendments. The LWVUS position then becomes the basis for action and advocacy.

So how can you participate and at what level do you want to participate?

A committee is being formed to present or arrange for a presenter for our November 5 You do not need to have any knowledge about constitutional amendments to be on the committee. It is expected that the committee will meet up to 4 times, with a schedule that works for all members. The committee will use the LWVUS Constitutional Amendments Study Guide (thank goodness we don't have to create our own from scratch) which can be accessed at: http://forum.lwv.org/member-resources/article/constitutional-amendment-study-guide. If you want to be on the committee or have questions about the process, please contact Pat Landes at landes.pat@gmail.com or 309-648-3504. She will be coordinating until co-chairs volunteer.

If you are not interested in being on the committee but are interested in the issue, you can read the study guide mentioned above, read the materials in the VOTER (the first article is in this VOTER at the end of this announcement, and/or attend in participate in the presentation and consensus process.

Please note that the study is broken into 3 parts, each having consensus questions:

Part 1 – Considerations for Evaluating Constitutional Amendment Proposals (5 consensus questions)

Part 2 – Aspects of an Article V Constitutional Convention (6 consensus questions)

Part 3 – Balancing Questions (2 consensus questions)

Here is the first article for background:

This short paper presents a synopsis of the Chicago Public Law and Legal Theory Working Paper titled "Constitutional Amendments and the Constitutional Common Law," written by Professor Adrian Vermeule, Professor of Law at the University of Chicago in 2004, available at http://www.law.uchicago.edu/files/files/73-av-amendments.pdf (accessed July 2, 2015).

The gist of the paper is that we should not be predisposed against using the Article V constitutional amendment process. Vermeule critiques the position attributed to Kathleen Sullivan and others that there should be a general presumption against amending the Constitution. Such a view favors constitutional change through court decisions as opposed to constitutional amendments. He argues that this position, when widely adopted, exerts a drag on the amendment process that may do more harm than good.

By disadvantaging the amendment process, the court-centered view tips the balance in favor of constitutional change brought about through common law judicial decisions, which he believes hold equal or greater peril. The alternative to the amendment process is continuous reinterpretation of the Constitution left to the courts – that is, "to an ongoing constitutional convention whose delegates are all judges (and hence all lawyers)." He points out that *no member of another profession has ever been appointed to the Supreme Court*, although no law prohibits the appointment of others. Whatever the other advantages or disadvantages of the amendment process, it would presumably involve a more diverse group of actors.

In responding directly to Kathleen Sullivan's paper, he argues that the case against the Article V process is based on a fallacy: that the alternative to constitutional amendment is stability, when in fact the alternative is continual judicial updating of the Constitution, which often produces as bad or worse results than the constitutional amendment process does.

Here are some of the prominent arguments that Vermeule counters:

- Amendments politicize the Constitution: so, he argues, do judicial interpretations of the Constitution, as we have seen in the continuing political struggle after *Roe v Wade* and as we may yet see with decisions on campaign finance, the Affordable Care Act, and same-sex marriage.
- <u>Amendments clutter up the Constitution</u>: the real alternative to lengthy text in the Constitution is to have a complex and tangled underbrush of judicial decisions. "A complex society will produce complex constitutional law; the only real question is whether it is good to outsource ... complexity... to the adjudicative process."
- Amendments represent a "mutiny" against the Supreme Court: on the contrary, more amendments would leave
 less room for judicial flip-flops, over-rulings, creative and novel interpretations. An increased rate of amendment
 might actually legitimize the Court.
- Amendments have bad unintended consequences: judicial updating may also have unforeseen consequences, as may judicial inaction or amendment restraint. "Worry about perverse consequences ... yields paralysis, not safely."
- Amendments should not encode "mere social policies" but should expand individual rights or improve government structure: why shouldn't other types of amendments be considered as circumstances change? The fact that the previous 27 amendments can be largely categorized this way is "curve fitting" on a very small number of amendments.

In conclusion, Vermeule argues that both the amendment process and the judge-made constitutional law may be appropriate alternatives in different circumstances.
