March 2, 2017 event, Alternative Voting Systems That Illinois Should Evaluate

The League March meeting is a program on Alternative Voting Systems that Illinois Should Evaluate, at **6 pm. on Thursday, March 2** at the Advanced Medical Transport (AMT) Building Auditorium, 1718 N. Sterling, Peoria, IL 61604.

Edward Burmila, Assistant Professor at Bradley University's Political Science Department will explain the vote by mail system that Washington and Oregon use. They do not have polling places and election judges. All ballots are sent by mail with a candidate information booklet. All ballots are returned by mail or drop off. The questions are many about this system: do they get a high turnout, does this encourage candidates to run for office, is there much fraud?

Mr. Burmila will also talk about California's "top two" primary voting system, which is credited along with redistricting reform in changing California's budget problems, voter turnout, turnover in offices, etc. This is another reform that Illinois could evaluate.

The event is free and open to the public. Bring your friends.

Legislative Interview

On February 20, I had an opportunity to join two League members, Cheryl Budzinski and Kathy Leson, for a visit to Representative Ryan Spain's office to interview him on several issues. The State League encourages members to participate in the Legislative Interviews which is a discussion with members of the state legislature on specific issues. Spain and discussing the League's stand on Campaign Finance issues, such as nonprofits 501(c)4 and 501(c)6, term limits and the Illinois Campaign Finance Reform Task Force. Representative Spain was very welcoming and gracious with his time.

I would certainly get involved with this process again. It was interesting and rewarding to meet with a local legislator and establish communication on important topics. The State League outlined a process to use for this, as well as provide talking points on the selected issues that can be used for the meeting. Greater Peoria League of Women Voters March 15, 2017 event

Do you have questions about Charter Schools? The League has a position on Charter Schools.

The Greater Peoria League of Women Voters will discuss Charter Schools at its Drinks & Dialogue event, 5:30 – 6:30 pm on Wednesday, March 15, at the Lariat Steakhouse, 2322 W. Glen Ave., Peoria.

Leaguer Lisa Uphoff will discuss the League's position on Charter Schools and explain the relationships with public school districts and funding.

The League of Women Voters of Greater Peoria participated in the state League's Charter Schools study in 2014-15. LWVIL's position is: "The League of Women Voters of Illinois supports accountability, transparency, and equity in the use of public funds for education, including charter schools...." LWVIL believes (partial list):

- Adequate funding is needed for all public schools including charters, but the financial impact on the local school districts should be evaluated prior to granting charters
- Existing charters should be evaluated at least every 5 years
- Charters should be revoked if they repeatedly or egregiously fail in 7 specific areas
- Employees have the right to unionize
- Authority to renew or authorize exclusively should be done by the local school board
- Local voters should be able to override any ISBE decision overriding a local school board decision re: charters
- Good communication on effective innovations is needed among all public schools

Further, four concerns about charters are: financial impact on school districts; privatization and profit-making; lack of transparency; and virtual education.

League members and the public are invited to participate in the dialogue, to be facilitated by League secretary, Lisa Uphoff.

The event is free and the public is invited. Refreshments are available for purchase.

Observer Report for Peoria Election Commission

February 14, 2017

The Peoria Election Commission held their monthly board meeting on Tuesday afternoon at the Election Commission offices. They started by approving the payment of various bills and the changes to several polling places. All county polling places are now set, except for the one at Lake Camelot which has an issue with accessibility because of a bridge being out. That change will take place after the bridge repair is finished. Single polling places were merged in order to save on the cost of elections. One polling place was changed because of a poor cell phone signal required for same day registration.

Director Tom Bride also briefed the board on the progress of moving into the new location. Some mold and asbestos has been found in the building. The county engineer is working with the owners to get the needed repairs done. In the interim, the county is paying rent and utility bills, even though they cannot use the building. The election commission has no control over these payments.

The calendar for early voting in the general election was approved by the Commission. It will start on February 23, for those precincts not holding a primary and March 10, for those precincts holding a primary. Early voting will be available for one day in Brimfield, Chillicothe, Alpha Park, and Dunlap, and for one week at ICC North.

The Commission also gave the director permission to make small technical changes to precinct lines when parcels are annexed or errors are detected. The need for this was apparent after Princeville annexed two properties recently. This change would put the properties into the precinct of the town of Princeville rather than the rural precinct.

The next meeting of the Election Commission will be on March 9, 2017, combining the canvas of the primary with their regular meeting.
