LWVGP studied ownership of the water distribution system beginning in early 2016 and determined its position in 2017.

POSITION

Water is a necessary resource for human life, not a commodity. The most important attributes of a water utility are: transparency; local control of rates and quality among other issues; local governance which is co-located with the water supply and service area; public oversight; high quality service; competitive rates.

The LWVGP believes financial analysis of public ownership of a water utility is warranted.

LWVGP supports ownership of the water and its distribution system that:

- Is committed to Central Illinois' water needs as a priority.
- Charges water rates that reflect local costs and local infrastructure maintenance.
- Is committed to transparency to insure information is easily accessible to the public about the rates, cost, supply and quality of Central Illinois' water and distribution system, including maintenance is most important.
- Allows water quality standards to be determined locally.
- Protects the San Koty aquifer and Illinois River for the use by future generations.
- Can use water more effectively as an economic development tool under local control to meet local needs.

OBJECTIVES

Water Rates

1. The price of residential water must be competitive with other local communities.
2. Water rates must be set based on expenses specifically in our service area.
3. The public must be notified of rate setting. Requests for changes to the rates must be explained at local meetings and online.
4. A detailed breakdown of current and projected costs specific to our local supply and service area must accompany all rate setting and change requests.
5. Capital costs for locally sourced water treatment and distribution must be available to the public.
6. Water rates must be set locally rather than by an appointed state board in Springfield.

Water Supply & Quality

1. Information on water source (aquifer and river) reductions from water usage must be easily accessed in order to allocate resources more equitably and better plan for the future.
2. Consideration of water-intensive business and industrial customers must include whether they jeopardize water availability.
3. Local approval must be required if local water is exported out of the area to safeguard our water supply and put Central Illinois' needs first.
4. Easy access to local water quality test results should be available.
5. The ability to implement drinking water quality standards more stringent than state or federal standards should be possible.

Maintenance of Water System Infrastructure to Include:

1. Eliminating water loss in the distribution system should be a priority.
2. Adopting the latest proven water treatment technologies.

Public Health

1. Local drinking water standards should change as the scientific consensus on what constitutes safe drinking water changes.
2. Local water analysis results should be included in public health reports and be available online.
3. Local meetings should be held and online explanations be developed to inform the public about possible health concerns with water treatment changes and water quality results.

Water System Encourages Economic Viability of the Region by:

1. Using water availability to direct future growth of the city and region.
2. Using water availability to promote business development.
3. Having a well-run customer support function able to respond quickly to complaints.
4. Having a skilled, responsive management team to support the needs of local businesses via an open and transparent decision-making process.
5. Considering public ownership of a water system as a positive aspect of economic viability versus a national corporation as a negative with regards to economic development.

Water Conservation:

1. Is important for future generations of Central Illinois residents.
2. Should include incentives for customers to reduce their water usage by the water company.

The Impact of the Neighborhood Safety Act
and How the Act Can Make Communities Safer and Reduce Overuse of Prisons

Wednesday, April 19, at 5:30 p.m., at the Lariat Club, 2232 West Glen, Peoria.

The League of Women Voters Drinks & Dialogue program on April 19, will discuss the Neighborhood Safety Act and how it will impact victims and perpetrators of violent crime. This bill was introduced into the Illinois House of Representatives by Representative Jehan Gordon Booth and was recently signed into law by the governor.

Sponsor Il. Rep. Jehan Gordon Booth will be leading the discussion.

The legislation will offer trauma recovery services for victims of crime by establishing a pilot program to provide support services to victims of violent crimes, including counseling, financial assistance, help relocating and guidance as they try to navigate the legal system.

The Neighborhood Safety Act also provides inmates with the opportunity for rehabilitation services, including job training and substance abuse programs. It also gives judges the freedom to give appropriate sentences, with the hope that the state can see a reduction of 25% in the state prison population by the year 2025. The League of Women Voters has historically taken positions for safety of individuals and communities and for changes in sentencing guidelines.

League members and the public are invited to participate in the dialogue on Wednesday, April 19, at 5:30 p.m., at the Lariat Steakhouse, 2232 West Glen. League member Jan Deissler will facilitate the dialogue.

There is no cost to participate. Refreshments are available to purchase.

Observer Report – SPRINGDALE CEMETERY BOARD

Al Andrews who recently retired from the management authority was given a service award for his dedicated service to Springdale.

The manager's report included that he:

- is contacting holders of unused mausoleum crypts looking to identify available inventory.
- is investigating to identify equipment to scan the historic records with the hope of electronically storing information to help preserve information and reduce use of the historic documents.
- has decided that the dedication of the new entrance will not happen in conjunction with this year's Memorial Day program because of scheduling complexity.
- is looking at a possible opportunity for the cemetery that he is investigating because local funeral directors have unclaimed remains.
- will be scheduling individual meetings with new authority directors to discuss various topics.
- also reported:
 - Mausoleum Roof condition & repair options ranging from \$60,000 for full replacement to \$3,000 patching. Patching recommended.
 - Prospect Road Entrance Project. First phase done. Next phase approved at last meeting was discovered to be \$8,000 over budget. Negotiated, 3 contract reductions to get back to budget. Based on discussion at previous meeting, performance bonds were removed retroactively from front gate project.
 - Tree & stump removal contract under negotiation by the manager.
 - Pet Cemetery Program no progress, because access is a problem, with erosion on the road.

Observer Report: PEORIA CITY COUNTY LANDFILL COMMITTEE

The first City County Landfill Committee meeting chaired by County Board member Steve Morris was on March 15th. Mr Morris's appointment was announced at the February meeting. Past chairman Les Bergsten continues his many years of service with the committee as an appointed citizen member. Sharon Williams is on Landfill Committee to replace County Board member Lynn Scott Pearson who did not run for re-election to the County Board.

Discussion continued on issues regarding free residential pick-up truck size loads of trash that are brought to the landfill. This topic began several months ago when Mr. Morris raised concern about a resident who phoned him saying they were charged an excessive amount for discarding a couch. Landfill management reported on further researching their records and finding that less than 2% of citizen pick-up loads are charged a fee and that typically bringing just a couch would not result in a fee. There are instances when the gate is very busy or it could be possible an error occurred resulting in the cost. A fee does get applied when the load is a ton or more. A \$5. fee is assessed if a citizen brings in more than one pick-up load a week. It was pointed out that the number of free pick-up loads has gone up over the years, while county population has not.

About 15,000 citizen pick-up loads of trash were received at the landfill. It is unusual for a landfill to provide free loads to local residents year-round. The comment was made that many citizens may not realize bulky items can be picked up at the curb by phoning the garbage hauler ahead of time. Citizens can phone the County Recycling Office for more information on options.


