## POSSIBLE MANAGEMENT STRUCTURES OF THE WATER COMPANY

One in the series of special meetings to educate ourselves and the public about "Due Diligence" and possible management options- if Peoria were to purchase the water system- was held Saturday, July 29, 2017. One possible management would be similar to the **Greater Peoria Sanitary District. Stan Browning Executive Director** of GPSD explained the management setup of GPSD and answered many questions from the League and audience. There was a great turnout at the meeting with standing room only.

Our League position on ownership of the water distribution system does not address management of the water utility if the city should decide to purchase. However, the CEO Council Report specifically lists six management/operations options.

Two of those options are:" independent government water agency; and, consolidating the water system with an existing government, like the GP Sanitary District."

GPSD is a municipal corporation. Their rates are completely usage based rates. This is unlike the IL American Water rates which charge a fee based on the size of your pipe going into your house PLUS additional usage based rate.

GPSD's rates are significantly lower than Urbana, Downers Grove, Naperville, Rockford, and Wheaton. (However, the City of Peoria already has fees that are added to our GPSD usage bill related to their capital work and Combined Sewer Overflow fee. Those fees are listed separately on your bill.) Mr. Browning sighted many municipalities with and without "sanitary districts."

The GPSD Board members are appointed by the Peoria County Board Chairman. This has worked well with no political complications. Usage rates are assessed completely based on costs - including capital costs- which are approved by the GPSD Board. Their GPSD Board approved budget is not approved by any other governmental unit, and is set by the GPSD trustees.

GPSD is transparent with noticing their meetings, agendas, and minutes. Stan welcomes citizens to attend and speak at "citizens remarks" at their Board meetings and offered to arrange a tour of the facility. GPSD makes decisions on their large capital improvements based on priority - reliability, asset management, and return on investment.

GPSD's largest user is ADM, and the second largest are the Peoria hospitals. GPSD has an agreement with IL American Water which works well for GPSD to get IAWC data on water meter readings (to determine GPSD bill) and for water shutoff if GPSD bill is unpaid. Both include a fee to IAWC. No other shared services and purchases have been found to be compatible.

The overall condition of their system is "aged and stable." Treatment facilities are current. They have a program in place to sustain the sewer system. Capacity is adequate. Some of their employees are AFSCME labor union members.

GPSD supported the City and County's economic development efforts with Growth Cell infrastructure including assisting with financing, although there was no direct subsidy.

### **OBSERVER REPORT: PEORIA PARK DISTRICT BOARD MEETING July 24, 2017**

Agenda Issues Relevant to LWV state or local positions or programs:

#### 1. Riverfront Program & Policy Advisory Committee

The Riverfront Park apartments project will begin Phase 1 in the fall of 2017. Board members and some attendees discussed concerns over the loss of green space for entertainment events to the apartment development project. (Editor's note: The National Park Service has not yet approved this development.)

Concerns included the possible impact upon future revenue for the city if larger entertainment events can no longer be accommodated. The City of Peoria has encouraged the Peoria Park District to attract larger venues to the Riverfront and may not be fully aware of the restrictions the Riverfront Apartment development may place upon future entertainment planning. The board will informally provide more information to the City of Peoria on this matter. Formal communications with the City of Peoria may be warranted in the future.

In addition, noise complaints from the Peoria and East Peoria residential areas in proximity to the entertainment events were mentioned. Events must now end by 11:30 pm in part due to those complaints. An East Peoria resident who has worked with East Peoria officials on similar noise issues offered information and assistance with ongoing efforts to minimize noise problems for residents.

#### 2. Relocation of LeTourneau Statue & House (new business)

Successful fund raising and logistical arrangements for moving the historical monument from Glen Oak Park and the LeTourneau house to the Wheels of Time Museum were reported. Lead paint was removed from the inside and exterior of the house. The Board approved the agreement with the Wheels of Time Museum for the relocation of the statue to Wheels of Time near the LaTourneau house.

#### 3. Smoking Restrictions for Park Facilities (new business)

The Board approved initiating the extension of smoking restrictions to the park district playgrounds, shelter areas, and park district vehicles. The process of announcing the changes and putting proper notification in place will follow the required timelines.


### **Voter Service Report**
