The Chillicothe Library will also be hosting early voting for the General Primary Election on March 16 and 17.

Peoria County Election Commission Report Tuesday, February 20, 2018

The Election Commission meeting this month was the shortest meeting I have ever attended! Even without director Tom Bride, this commission and its employees work very well together. After finally getting clearance about who could be on the ballot, early voting started at the downtown office on Monday. As of Tuesday afternoon 32 votes had been cast and 252 ballots mailed. Training for election judges will be Saturday, February 24, postponed from a previous date due to the weather. March 5, will be the first day for voting outside of the downtown office. Federal Warehouse had the only bid for moving election supplies for both 2018 elections. Their bid of \$5,600 was in line with past expenses and so was approved.

The Brandywine facility is current on the established timeline. Once the engineer signs off, it will go to the County Board hopefully in April, so it can be let out for bids.

The Elsamny case seems to finally be over. Mr. Elsamny had 30 days after the January 9, decision to file an appeal for a rehearing. The chair had not heard that he had done that, in which case the lawsuit is finished. Chair Collins will check with the commission's attorney to be sure and let the commissioners know.

Candidate Information

Please go to <u>www.lwvil.org</u> and select **Voter Guide**. This is a new initiative by our state League partnered with nonpartisan Ballot Ready to provide information on all the candidates to the public.

BallotReady uses information available on the internet and from various publications to populate the statewide candidate information. Our League decided to include our local candidates in Peoria and Tazewell and sent questions to ALL local candidates on the Peoria and Tazewell County ballots. We asked for the specific information on their background, requested a photo, to answer the question of their priorities for the office and how they would achieve those, and offered to include FaceBook, website, twitter information if they are campaigning using social media.

It was challenging because we sent the request by email and found most "spam" filters stopped our request. After follow-up phone calls and re-sending the request, we received many responses. Thanks to those candidates.

We have submitted referenda on the ballots in Peoria and Tazewell Counties.

Once the Voter Guide is opened, it asks for your street address and which ballot you want and shows your candidates. Click the "Questionnaires" tab. Then click "priorities", then "strategy", then "motivation." It is a work in progress. **Try it!**

A BIG Thank you to Peter for all his work emailing and putting responses into spreadsheets,

submitting, etc. We plan to track how much the Voter Guide is used in our area to see whether worthwhile to do this again.

This is one way LWVGP thought we could help local candidates to get their information out to the voters, so voters can make a more informed decision at the ballot box. I voted. Have you?

Observer Report: Peoria Township, Feb 22, 2018, Budget Committee Meeting

Those attending: Supervisor Frank Abdnour, Assessor Max Shlafley, Collector Patrick Nichting, Clerk Beth Ball, Attorney Tim Bertchy, accountant doing the township audit, Bookkeeper Lynn Green, Holli Heinz, and Connie Duffy. Absent: liaison Chuck Grayeb. Also in attendance: Cheryl Budzinski, LWVGP.

Discussion included:

- The expense cuts made such as Abdnour cutting transportation costs, use of vouchers has temporarily lowered the General Assistance with clients opting out.
- Shlafley suggesting drops in Administrative costs and stating he did not want to raise taxes.
- Reminder that supervisor added an Emergency benefit to help pay water bills which previously wasn't done. (There was no discussion whether this is a duplicated benefit that other agencies provide.)
- The Township goal is to keep a 50% (of their budget) reserve.
- Their goal this year was a 5% reduction in spending, anticipating the EAV going down 3-4%
- There are several large real estate holdings which have sold for a significant decrease in price which will go to the Board of Review, no doubt, for a lowered assessment.
- Difficult to project real estate tax revenue which funds Peoria Township, so they will take money out of their fund balance or reduce spending later in the year if the projected revenue is less than budgeted.

The Township Annual Meeting will be April 10. (End of that meeting.)

I have talked to Supervisor Abdnour and met with him asking changes in website to include: required listing of meetings for the year on the Township website as required by the Open Meetings Act; and listing of the number of individual clients and family clients helped in the last year and the dollar amounts per month. That information has been requested multiple times and had been included in the "downloads" section of their website in past years.

After other discussions between myself and Abdnour, the attorney for the township gave Abdnour specific statutes and court decisions that indicate that Township General Assistance cannot be limited by time; which contradicts practices by other Townships which do limit the term a person can receive General Assistance. And, "General Assistance" is referred to as "Temporary" General Assistance while awaiting acceptance into another governmental program.

In response to whether the various "assistance" programs are coordinated, the Supervisor suggested I talk to 2-1-1 which is a United Way program operated out of AMT which is something of a clearinghouse to people in need to tell them where to apply for the specific help needed. I am following up on that suggestion.
