# PEORIA CITY COUNTY LANDFILL COMMITTEE, Feb. 19

The Peoria City County Landfill Committee held its regular monthly meeting on Feb. 19 at Peoria City Hall, with Chairman Steve Morris presiding. Committee member Zach Oyler was absent.

During the Foth Engineering report, committee member Rick Fox asked for more information regarding one of the special waste products approved for disposal. Mr. Fox referred to several comments on the Material Data Safety Sheet regarding toxicity of manganese sulfate monohydrate. The substance was accepted at the landfill because it was not a Resource Conservation and Recovery Act (RCRA) hazardous waste.

The Foth review will turn down substances that could be a risk and they can also bring items of concern to the committee. The gate audit check showed all procedures in place and being followed.

Due to the cold weather only one load of landfill leachate was reported for the previous month. Waste tonnage receipts were up for January 2020, which has helped landfill revenues. About 13,168 tons were recorded compared to 12,200 tons in January 2019.

Waste Management staff could not be present for the meeting and had sent notification to the Chairman.

The Peoria Disposal Company report was given by Chris Coulter who informed the committee that the Request For Proposal for the planned lake rehabilitation and wetland enhancement project was released in mid-January. This work is in conjunction with the future construction of Landfill No. 3 by PDC. Mr. Coulter said four proposals have been received. PDC will be scheduling a meeting with the Illinois Department of Natural Resources regarding the wetland and water project, likely in March.

Foth Engineering gave an update on Landfill No. 1. They plan to have bids opened March 26 for several of the larger repairs needing to be done, with a one year contract and the option of three one-year extensions.

No new business was given. Chairman Morris commented that the State's Attorney office is again not present and as there were no specific legal matters before the committee he did not see a problem. He said he does want to be sure the Landfill Committee is not charged by the county when no legal assistance is provided. The next meeting is March 18. The meeting lasted less than 30 minutes.

## PEORIA COUNTY ELECTION COMMISSION, Feb. 11

The Peoria County Board of Election Commissioners held its monthly meeting Feb. 11, where Executive Director Tom Bride gave an update on the primary election in March.

Bride said 540 ballots had been mailed. Seventy ballots had been returned, including the first one, which came from Singapore! He announced that 150 people had already voted, and a few more early voters arrived at the office to vote during the course of the meeting. He expects 20 percent of voters to vote by mail.

Director Bride would like to look into finding the best replacement for the current voting system. The one in use now was purchased in 2005 and first used in March of 2006. He is concerned that the vendor will stop supporting the current machines.

Machines would not be replaced until summer of 2021 so as not to interfere with this year's election cycle. He is already holding discussions with Peoria County. He plans on sending out requests for information this summer so there would be plenty of time to make a decision. Planning is difficult because the state could change to more vote by mail. There is already discussion in the Illinois Legislature, and things can change very quickly.

### SPRINGDALE CEMETERY MANAGEMENT AUTHORITY, Feb. 18

Vice Chairman Bob Manning lead the Feb. 18 regular meeting; Chair Linda Daley was present by phone. There was a quorum. No additions were made to the agenda. The Jan. 21 regular meeting minutes and Jan. 27 special goal setting meeting minutes were approved. There was no public comment.

Goal Setting Meetings – Chair Linda Daley called the Special Goal Setting meeting to order at 3 p.m. Jan. 27 in the Springdale Cemetery meeting room in the Volunteer and Maintenance Building. A quorum was present. The meeting was facilitated by Peoria City Manager Patrick Urich, who will put together a summary. A second Goal Setting Meeting is scheduled from 3 to 5 p.m. Thurs., March 12.

General Manager Mark Matuszak lead an hour-long discussion regarding CloudPoint Mapping Conversion: the mapping process, challenges, delays and process to move forward. Mr. Matuszak laid out the timeline for completion and noted some of the difficulties that have been experienced during the process. There was also discussion regarding options for final payment for mapping completion followed by monthly maintenance fees, and under what circumstances should this phase of the project take place.

This discussion was followed by a presentation from a representative of CloudPoint who laid out the project's challenges and improvements to the over-all capacity to better serve families at Springdale Cemetery. It was agreed that Mr. Matuszak's view of the project was in line with that of the CloudPoint representation of the process. The Board thanked CloudPoint for their candor and thanked their representative for attending the meeting to update the Board.

The Board then further discussed the plan to move forward. It was suggested that the plan in relation to the project would be to: Define measurable progress goals. And clearly define expected deliverables to be met before scheduled payments with a goal for completion of the mapping project. This phase would then be followed with a maintenance agreement with agreed upon monthly fees.


